The Certified Law Enforcement Executive Program (CLEE) through the Colorado Association of Chiefs of Police is acquired through a combination of academic achievement; law enforcement experience at the municipal, county, state, or federal level; command experience at the rank of Lieutenant or higher; continuing education as a student or instructor; specialized training and service as a board member of a law enforcement association or community organization. This certification does not need to be renewed.

To be eligible for CLEE, you must have achieved the rank of Lieutenant or higher (exceptions may be made for lower ranks based on duties and organizational structure); be a member in good standing with the CACP, accumulate through education and experience, continuing education and organizational service, a minimum composite score of **1000 points**. It is important that you complete point totals for each section.
